OVERALL COMMENTS

This is a good case but you struggle to explain it clearly. Your literacy skills are not sufficient enough for me to understand the details of the case. I have used the underline tool in the grading window to highlight some of the most difficult areas and incorrect words. You also have incorrectly identified the court the case was heard in by name it: "the US Incomprable Court" there is no such court in this country, or in any other country. Further you write that a subpoena was issued to the defendant by the: "Government Fabulous Jury". Again there is no such legal entity in this country. I found it extremely difficult to sift through the information to be able to understand the facts, context and ruling in the case. Additionally you state "the feeling of the court" that is incorrect, courts issue rulings not feelings. Base on this I strongly suggest you visit the writing center for additional help with the assessments in this course as well as contact your tutor or coach for additional assistance in preparing the next attempt.

DISTINGUISHED:

Analyzes how a legal case could impact businesses, including both positive and negative impacts.

Comments:

Explain how a legal case could impact a specific organization.

COMPETENCY

Evaluate legal options to create a business entity.

NON_PERFORMANCE: Does not explain how a legal case could impact a specific organization.

BASIC:

Discusses a legal case in the context of a specific organization, but does not explain the relationship or significance to a specific organization.

PROFICIENT: Explains how a legal case could impact a specific organization.

DISTINGUISHED:

Explains how a legal case could impact a specific organization such that an executive team will understand the implications of the legal decision.
